GOVERNOR O'MALLEY ESTABLISHES JUDICIAL NOMINATING COMMISSIONS

Executive Order for Commissions to Nominate Appellate and Trial Court Judges

ANNAPOLIS (**April 27, 2007**) – Governor Martin O'Malley today announced the creation of an Appellate Courts Judicial Nominating Commission and sixteen regional Trial Courts Judicial Nominating Commissions. Each commission will be responsible for recommending to the Governor the names of persons for appointment to the appellate and trial courts of Maryland.

O'Malley issued Executive Order 01.01.2007.08 – Judicial Nominating Commissions – earlier today and announced the appointment of twelve individuals to serve on the Appellate Courts Judicial Nominating Commission. Under this executive order, the Maryland State Bar Association will select five additional members for the Commission.

"I am proud to issue this executive order to bring together this diverse and competent commission to aid in the appointment of highly qualified persons to serve on Maryland's appellate and trial courts," said Governor Martin O'Malley. "The Appellate Courts Judicial Nominating Commission, under the leadership of Shelia K. Sachs, represents the best legal minds in our State, and I look forward to appointing members to the Trial Courts Commissions in the weeks ahead."
